

This past November at the 23rd Annual 3 Rivers Wet Weather (3RWW) Conference, Jason E. Stanton, P.E. and Jacob C. Bajek, P.E. of LSSE participated in the panel discussion, Developing a Multi-Municipal Partnership to Reduce Inflow and Infiltration. With Jason as the moderator, Jacob, Abigail Corrigan (Bethel Park) and Jennifer Slagle (Gateway Engineers) shared their experiences in developing a multi-municipal partnership to solve the overflows within their joint sewershed. The engineers presented the strategies, outcomes and considerations to show the evolution and development of a functional partnership. With the facilitation of 3RWW, each municipality shares tasks, invests resources and fully participates in the planning and implementation toward the ultimate goal of reducing inflow and infiltration, and collectively complying with the municipal consent orders requirements.



# <u>3D Laser Scanning of</u> <u>West Overton Village</u>

LSSE was contracted to provide a yearly comparison of seven buildings at the West Overton Village by method of 3D Laser Scanning to be used to monitor the physical condition of the buildings and show any deformations in the walls. Survey control and prior point clouds were provided to LSSE in order to compare one year from the other. Our field crews utilized the prior control to locate the buildings and generate a point cloud. LSSE's point cloud and the prior point cloud were then overlaid to generate a colorized point comparison map paired with a histogram for each wall which detailed any movement over the past year.





## Avalon Borough MS4 Stream Restoration Project

On Saturday, November 19, 2022, LSSE staff assisted Avalon Borough with a tree planting event at the Borough Park on New Brighton Road. The goal of this project was to restore a section of Spruce Run in order to satisfy the Borough's Municipal Separate Storm Sewer System (MS4) Pollutant Reduction Plan (PRP) Requirements. The Borough had to restore 325 linear feet of stream in order to meet its PRP Requirements. LSSE assisted the Borough in selection of the stream section, permitting and design, and construction of the project. Borough Public Works completed the grading activities as well as installation of Scour-Lok SDS wall blocks. Approximately 3,000 bare root plants were installed to establish a riparian buffer. LSSE has assisted several municipalities in design, permitting and construction of stream restoration projects to satisfy PRP requirements and looks forward to continue serving our Clients' needs.




# 2023 New Brighton Elementary STEAM DAY
